Dear Sir Simon,

As Independent Anti-Slavery Commissioner, I am writing in connection with my statutory responsibility to encourage good practice in the prevention, detection, investigation and prosecution of modern slavery offences and the identification of victims.

Since taking up this post in May 2019 I have established a health working group to bring together key stakeholders from across the health and anti-slavery sector. I have been encouraged by the dedication and commitment across the sector to ensuring that health professionals are adequately trained and equipped to identify victims, respond to their needs and refer them for further support. However, at our most recent meeting at the start of October, I was disappointed to learn that the NHS England Modern Slavery Network is to be disbanded with modern slavery related activity to be mainstreamed into the three priority workstreams that have been identified: tackling serious violence, domestic abuse and preventing child sexual abuse/exploitation, as well as the broader adult and child safeguarding networks.

Whilst I acknowledge the rationale for this shift and the desire for responses to modern slavery to be considered as part of the broader response to safeguarding vulnerable people, it is still a relatively young and emerging agenda, victims of modern slavery may have specific health needs and there is still a considerable amount of work to be done ensure a consistent level of awareness among frontline professionals. Modern Slavery has an impact on physical, mental, emotional, relational and social well-being and is therefore a global public health issue. I along with others from the working group are concerned that by mainstreaming this work at such an early stage and therefore removing the governance and accountability currently in place that this could stall some of the good progress that has been made by the health sector in recent years. It is felt that more time to raise awareness of modern slavery as a separate agenda would be beneficial.

I therefore seek assurance from you that modern slavery will be incorporated within the relevant agendas for these newly formed groups and that the membership will include experts who can speak with knowledge and insight in relation to both adult and child victims of modern slavery.

I look forward to receiving your response. In the interests of transparency, I request that you respond in a way that enables me to publish your letter on my website.

Dear Dame Sara,

Many thanks for your letter of 19 October 2020 to Simon Stevens in which you expressed concerns regarding the incorporation of the NHS England Modern Slavery Network into the Safeguarding Adults National Network. I am writing to provide assurance that this will deliver benefits in terms of promoting wider awareness of modern slavery and in addressing the associated healthcare priorities you highlight.

The Modern Slavery Network has been very successful over the past few years at raising the profile of this important work, and NHS England and NHS Improvement remain fully committed to the values of anti-slavery and preventing modern slavery and human trafficking.

NHS Safeguarding undertook a review of national workstreams, following the cross-Government-led Hidden Harms summit. Learning from the experiences of individuals, families and communities of the impact of the global pandemic, the review was intended to strengthen the focus of modern slavery strategies by integrating expertise, training and resources into clinical networks that are relevant to the eradication of slavery and human trafficking.

Going forward, the Safeguarding Adults National Network, tackling serious violence and child sexual exploitation, will include modern slavery and human trafficking as a core priority. The NHS has done a tremendous amount of work in the field of modern slavery and human trafficking, and we are a key partner with others in detection and prevention. The expertise we have developed will be represented in all our national networks by key safeguarding leaders. These new, integrated networks will put the prevention of modern slavery and our anti-slavery approaches across the NHS at the core of all our safeguarding networks.

Preventing modern slavery remains core to our Safeguarding Assurance & Accountability Framework, our new Safeguarding Commissioning Assurance Toolkit and our trauma informed and contextual safeguarding training materials.

I hope this provides helpful assurance of our continuing organisational commitment to this important agenda.
